

In this session, we explore the award-winning documentary Crip Camp: A Disability Revolution, codirected, produced, and written by Nicole Newnham and Jim LeBrecht. We will be joined by LeBrecht and author Denise Sherer Jacobson, who is featured in the film, served as the story consultant, and was a camper and camp staff. Crip Camp profiles a summer camp for young people with disabilities in upstate New York in the 1960s. The camaraderie and relationships built at Camp Jened laid the foundation for the disability rights movement of the 1970s and the eventual passage of the Americans with Disabilities Act in 1990. The session will also include the presentation of our 2021 Catalyst Awards, sponsored by Comcast NBCUniversal. During this session, presenters will share data and stories from the public health emergency. Particular attention will be paid to COVID-19 immunizations for the IDD population based on geography, age, type of disability, residential setting, and timeliness from each state's phased priority dates for people with disabilities. The American Rescue Plan and the 10% Federal Medical Assistance Percentages (FMAP) bump provide a unique funding opportunity to help accelerate changes in home and community-based services (HCBS) policy for critical updates to services and supports, which will determine the trajectory for the future. The presenters will share lessons learned from the pandemic and its disparate effect on individuals with IDD along with their influence on planning for the future on topics including employment, moves to more integrated setting, the DSP workforce crisis, and self-direction.

Grant Writing 101: The Basics and Beyond*

Preparing First Responders for Behavioral Crisis

Many families struggle with contacting first responders in the event of an emergency. The training that law enforcement receives may be on the complete opposite end of the spectrum of what will work to de-escalate a crisis with a person with a disability. This session will provide participants with the tools to work collaboratively with local first responders on how to best respond to a crisis situation. Participants will learn about de-escalation techniques, safety plans for other household members, home and support services, and more.

Strategic Response and Lessons Learned From COVID-19 for Future Crises* Sarah Baier, AHRC New York City; Elizabeth Lynam, AHRC New York City; Philip Proctor, AHRC New York City SUPPORTS AND SERVICES INTERMEDIATE

AHRC New York City was in the initial epicenter of the COVID-19 pandemic in the U.S. In this session, their strategic responses will be shared, including lessons learned, best practices, and effective tools so that we can be better prepared together and stem the impact of the next public health crisis. This session will deliver an operational approach and supporting tools that are adaptable and actionable for any provider organization. It will also cover a roadmap for effectively responding to the onset of a crisis situation to safeguard the health of individuals and staff, the quality of services delivered, and the sustainability of operations. The models presented in this session were used by state entities to inform policies, data collection requirements, and operational guidelines across New York State. AHRC New York City's rapid change in operational management and data collection strengthened its ability to advocate and influence the direction of state and local government responses.

The Benefits of Automatic Enrollment and Auto-Escalation

During this session, participants will learn and understand how to better help their employees get on the right track early to prepare for retirement. By automatically enrolling employees at a small predetermined amount and gradually increasing savings annually, employees can start to plan for their retirement without stress. Employees can opt out if they choose, however, statistics have shown that more than 90% of the time participants do not opt out. These automatic enrollment and auto-escalation features help individuals by using their inertia to work for them as opposed to working against them when they are asked to "opt in." Additionally, employees who have a retirement plan account with an employer are usually more emotionally tied to that employer, which can help reduce turnover and increase retention.

The Impact of Inclusive Post-Secondary Education

In this session, Martha Haythorn will outline her experience in an inclusive post-secondary education (IPSE) program by narrating her experience starting with the decision to go to college. Martha will walk through the process of applying for college, enrolling, and transitioning out of high school and into the postsecondary education world. Martha will give a first-hand account of the mentorship program at her school and will talk about the unique peer support model that Georgia Tech Excel uses, which has created an opportunity for her to reach her goals in independent living, social life, academic enrichment, and career development. This session will end with a short workshop on preparing for college and choosing the school that is best for each individual.

Access, Equity, and Inclusion: Sharing What Works

LEADERSHIP INTERMEDIATE

We want our advocacy and services to be accessible and inclusive of an incredibly diverse IDD community. We need to share information, create services, and host events that are welcoming to all. We also need to be equitable. This means working with and prioritizing the needs of underserved and marginalized communities, including communities of color, refugees, immigrants, the LGBTQIA+ community, religious minorities, older adults, and those who communicate in languages other than English. The Arc's network is powerful and can be a great source of innovation. In this interactive session, we will facilitate a knowledge exchange and elevate the work of chapters, self-advocates, and others working to center the experiences of those who are most marginalized in their communities.

Best Practices for Day Programs in Developing Successful Volunteer Opportunities* Patti Colombo, Volunteer New York!

SUPPORTS AND SERVICES ADVANCED

Volunteer New York!, an affiliate of the Global Points of Light Network, will share key insights and best practices used to collaborate with local chapters of The Arc in supporting their community engagement goals and enhancing their volunteer programs for individuals they serve. Volunteer New York! receives private funding to connect young adults with IDD to volunteer opportunities where they build job readiness skills through volunteering. This program successfully pivoted to virtual support and remote opportunities throughout the pandemic, which kept individuals connected with the community when they were unable to be in the community. In this session, you will learn what action steps to take to build stronger connections to volunteer sites, build better community relationships, and promote positive messaging on the impact of volunteerism for your organization and community. You will also learn how chapters can benefit from community-wide days of service, corporate engagement, and board and leadership development programs.

Partnering With the Department of Education to Improve Outcomes for Students* Jennifer Aprea, The Arc Tennessee; Theresa Nicholls, Tennessee Department of Education

Jennifer Aprea, Director of Family Engagement in Special Education for The Arc Tennessee, and Theresa Nicholls, Assistant Commissioner of Special Populations for the Tennessee Department of Education, will talk about the Family Engagement in Special Education (FESPED) project they implemented in 2018 to improve outcomes for students with disabilities by empowering families to be fully involved in their child's special education journey. The FESPED project works with schools, families, and advocacy groups statewide to provide resources, trainings, networking events, and more as a way to build the bridge between schools and families. In this session, you will learn about how this project formed, how it was funded, and the many ways it has enabled collaboration to the benefit of all students!

In this session, we will describe the social enterprise business model fostered by arc Thrift Stores to maximize profits on behalf of their mission to enhance the lives of individuals with intellectual and developmental disabilities. Presenters will describe in detail how the stores function and how they can be an amazing fundraising tool for other chapters across the state.

In order to garner substantive awareness, which will lead to unconditional acceptance, we need to start talking about what's not talked about. Join Russell Lehmann as he provides captivating, profound, and educational insight into four areas of autism that are rarely talked about: intrusive thoughts (the trauma you will never know about); suicidal ideations; anger toward the outside world; and lack of empathy.

Direct Support Workforce and COVID-19 National Report*

SUPPORTS AND SERVICES INTERMEDIATE

The Institute on Community Integration and the National Alliance for Direct Support Professionals conducted a study with approximately 9,000 direct support professionals (DSPs) from across the country on their experiences of working during the COVID-19 pandemic. In this session, findings from an initial survey, a six-month follow-up, and a 12-month follow-up will be shared, describing the challenges faced by DSPs and the people they support and the underlying systemic problems that have had devastating effects on the direct support workforce. Topics will include the pandemic's impact on turnover and vacancy, hiring practices, staffing challenges, safety measures, DSP work life, and those exposed to and diagnosed with COVID-19. The disproportionate impact of COVID-19 on people from diverse racial and ethnic backgrounds will also be explored. Recommendations for what is needed moving forward to address future crises for DSPs and people receiving supports will also be provided.

Person-Centered Practices in a Post-COVID World

County quickly established a robust offering of remote supports in partnership with people served and their families. You will also learn about The Arc of Frederick County's current plans and advocacy to continue offering braided in-person and remote supports at home, in the community, and at work so that people with disabilities have equal access in all communities.

This session will provide an overview of how The Arc Mid-Hudson developed a former sheltered workshop space into a welcoming community-based inclusive arts center. Attendees will learn about how the pandemic impacted strategic planning and programming and how classes and events were implemented. The pros and cons to virtual programming will be discussed, including expanding accessibility and geographical reach and learned best practices. Attendees will take away the positive impact that building an inclusive arts center can have on connecting people with and without disabilities, creating an equitable platform for community participation and reciprocal relationship building, opportunities for employment, and providing cultural arts education.

Peer support is an under-utilized benefit in many home and community-based services programs. Yet research demonstrates that peer support is exactly what people with intellectual and developmental disabilities need to recognize their own potential for getting a job or living on their own. Building Inclusive and Equitable Makerspaces: Making the Case for Accessibility Amelia Anderson, Old Dominion University; Abigail Phillips, University of Wisconsin-Milwaukee

LEADERSHIP BEGINNER

In this session, presenters will discuss ways to make the case for incorporating accessibility into makerspaces to administration, colleagues, and the public. This presentation is based on an ongoing grant-funded study investigating how public libraries can construct more inclusive and accessible makerspaces for everyone, but particularly for individuals with disabilities. While the focus may be on makerspaces, this work and presentation translates to other spaces where accessibility is missing, yet greatly needed. A focal point of this session will be to equip attendees with the skills and language needed to justify the creation, management, and promotion of such a space.

Health Advocacy Services

SUPPORTS AND SERVICES ADVANCED

For years, health care has been moving toward telehealth as its main system for non-emergency service delivery. When COVID-19 made leaving home a health risk, telehealth became the optimal procurement method for providers. However, benefitting from telehealth medical care requires patients to have basic digital proficiency and access to technology, both barriers for persons with intellectual and developmental disabilities (IDD). The session will detail The Arc's telehealth access and delivery strategy and will include an overview of health advocacy services: pairing adults with IDD with a health advocate who accompanies them to medical appointments, facilitates communication with their medical team, supports compliance with and comprehension of medical directives, transmits health history, and coordinates services among multiple specialty providers. Successful methods to increasing participants' access to technology and facilitating digital learning courses will be discussed along with a guide to The Hub, an online learning platform created as a solution to social isolation and to offer virtual classes.

Self Advocates Practicing Leadership During A Pandemic: Kansas Style

ADVOCACY INTERMEDIATE

The Self-Advocate Coalition of Kansas' collaboration with the Kansas Leadership Center dates back several years. Self-advocates in Kansas have attended leadership trainings at KLC and, as a result, have exercised leadership increasingly throughout the state. KLC has embraced this partnership from the beginning, welcoming accessibility audits and requests for plain language. Join SACK self-advocates in this session to discuss how this partnership has flourished. In December 2020, the State of Kansas hired the Kansas Leadership Center to conduct an Action Plan across the state to attempt to reduce the incidence of COVID-19 throughout the holidays. Once vaccines became available another effort was undertaken – Voices on Vaccination. In each case, KLC reached out to SACK for inclusion of the voices of self-advocates and individuals with disabilities. And Kansas self-advocates didn't disappoint!


